

**T&M ASSOCIATES-AUTHORIZATION FOR INVESTIGATION AND ESTIMATING  
CERTAIN ROAD IMPROVEMENT PROJECTS**

**WHEREAS**, road improvements are needed for Lafayette Avenue from Monroe Avenue to the Dumont town limit and Quackenbush Avenue from Depew Street to West Shore Avenue; and

**WHEREAS**, T&M plans design and construction administration; and

**WHEREAS**, additional preliminary roadway investigation and estimating of Virginia Avenue from Washington to Pershing (full block); Bedford from New Milford Avenue to Golfview; the full length of Seminole Avenue and the full length of Chestnut Avenue shall be performed, which will include a site visit at each street, contacting the DPW Superintendent to learn of any special needs of these roads in order to ensure future design corrects outstanding problems and they shall prepare probable estimates for construction to be used in obtaining bonding for future




work; and
