### ESTABLISHMENT OF DELINQUENT TAX RATE/PENALTIES

WHEREAS, N.J.S.A. 54:4-67 authorizes the Borough to fix a rate of interest to be charged for delinquent taxes; and

WHEREAS, N.J.S.A. 54:4-67, as amended by Section 29 of P.L. 1991, c.75, authorizes the Borough to fix a penalty of 6% to be charged to a taxpayer with a delinquency in excess of \$10,000 who fails to pay the delinquency prior to the end of the calendar year;

WHEREAS, the Governing Body has decided to charge the maximum interest and penalty allowed by law on delinquent taxes.

**BE IT RESOLVED**, by the Council of the Borough of Dumont; as follows:

- 1. For the year 2021 the rate of interest for delinquent taxes and Borough charges shall be 8% per annum for the first \$1,500.00 of the delinquency and 18% per annum on any amount in excess of \$1,500.00 except that, for any quarter if the taxes are paid during the first ten (10) days following February 1<sup>st</sup>, May 1<sup>st</sup>, August 1<sup>st</sup>, and November 1<sup>st</sup> there shall be no interest. If the office of the Tax Collector is closed on the 10<sup>th</sup> day of February, May, August or November this shall be extended to include the first business day thereafter.
- 2. For the year 2021 any taxpayer with a tax delinquency in excess of \$10,000 who fails to pay that delinquency prior to the end of the calendar year shall be charged a penalty of 6% of the amount of the delinquency.
- 3. The Tax Collector is hereby authorized to cancel any overpayment of taxes or tax delinquency which is less than \$10.00.

# AWARD CONTRACT TO MILLENNIUM STRATEGIES TO SUBMIT A GRANT APPLICATION FOR TROPICAL STORM ISAIAS RECOVERY FUNDS

WHEREAS, the President of the United States has declared Tropical Storm Isaias via a Disaster Declaration (DR4574) on December 11, 2020; and

WHEREAS, the Borough of Dumont has expended substantial sums in response to the Tropical Storm Isaias and may be entitled to reimbursement of funds from FEMA or FEMA programs as a result of the Tropical Storm Isaias; and

WHEREAS, the Borough of Dumont is in need of grant consultant services to apply for such reimbursement; and

WHEREAS, N.J.S.A. 40A:11-6.1 provides that contracts in the aggregate less than the bid threshold (\$44,000) but 15% of that amount of more (\$6,600) may be awarded after soliciting at least two competitive quotations, if practicable, and awarded to a vendor whose response is most advantageous, price and other factors considered; and

WHEREAS, the Borough's qualified purchasing agent has solicited at least two competitive quotations as set forth on the schedule annexed hereto and made a part hereof; and

WHEREAS, the firm of Millennium Strategies, LLC located at 60 Columbia Road, Building B, Suite 230, Morristown, New Jersey, had submitted a quotation to provide such services at a blended hourly rate of \$180.00 per hour for an amount not to exceed \$10,000.00; and

WHEREAS, the Chief Financial Officer certifies that funds are available under general administration professional services account 1-01-20-100-235 and this certification is now part of said resolution; and

WHEREAS, the Borough Council, on the advice of the Purchasing Agent, finds that Millennium Strategies, LLC has the necessary experience and expertise as a consultant to obtain FEMA grants and management and administrative professional services in seeking emergency appropriations from FEMA and Resolution #61 of the January 6, 2021 meeting, concludes that the award of the contract to Millennium Strategies would be most advantageous, price and other factors considered; and

WHEREAS, the CONSULTANT has completed and submitted a Business Entity Disclosure Certification which certifies that the CONSULTANT has not made any reportable contributions to a political or candidate committee pursuant to N.J.S.A. 19:44A-1 et seq. and P.L. 2004, c.19, as amended by P.L. 2005, c.51, or pursuant to Ordinance #1565 of the of the Borough of Dumont, which would bar the award of this contract in the previous one year period preceding the award of this contract, and that the contract will prohibit the CONSULTANT from making any reportable contributions during the term of the contract; and

WHEREAS, the Borough Council of the Borough has authorized the Mayor and the Clerk to execute an Agreement between the Borough and the CONSULTANT;
