Mayor Kelly recognized Senator Cardinale who was supposed to administer one of the Oath of Office, but arrive late.

Mayor Kelly called for a five minute recess.

The Governing Body thanked Bill Brophy for his dedication and service the past three years as councilman.

Mayor Kelly stated that there are several issues facing the Governing Body, among which is to decide which course of action would be best to establish a new borough hall. The D'Angelo Farm litigation is still pending. Another concern is flood insurance; residents are paying insurance although they don't have flooding issues. There was a meeting with FEMA at the County today. Taxes are always an issue; shared services are always being explored.

Councilman Hayes stated that his biggest concern was that since Mr. Paster is a
councilman in a neighboring town, there would be a conflict of interest if Dumont was
considering shared services with that town. He also does not think Mr. Paster would
have enough time to devote to Dumont since he is a councilman. He pointed out that Mr.
Paster has raised his rate from last year.

Mr. Paster responded that he has been on the Council since 2013, having been the choice of a Republican majority to fill a vacancy. He had actually been the Borough

attorney of Demarest and Dumont when a Shade Tree shared service was initiated, and it was not a problem. Mr. Paster agreed to charge last year's rate of \$140.

Councilman Manna stated that the position of Council President is the Council's choice. He had asked for support from the council members. Former Council President Zamechansky had communicated this to the Mayor. The Mayor felt that Councilman Hayes would be a good Council President. He said, however, the Council could vote to make Councilman Manna president. Councilwoman Zamechansky stated that this put Councilman Hayes in an embarrassing situation. Councilwoman Correa feels they should be working as a team and there should be better communication. Mayor Kelly promised to be more communicative in the future.

#15-43 Authorization of Advertisement for RFQ's for Financial Advisor and Arbitrage Rebate Compliance Consultant

Councilman Hayes asked for clarification. Mr. Paster explained that this is federally mandated. The Financial Advisor must be in place exclusive of the Borough Auditor and Bond Counsel. The Arbitrage Rebate Consultant is a separate position where there is a continuing debt disclosure requirement. Both could be handled by the same firm.

- 2. Christopher Snell, 84 Franklin Street, asked Mr. Paster if he could lower his fee, which he had already agreed to. Mr. Snell feels there should be an interview process for RFQ appointments.
- 3. Betty Krystiniak, 569 Prospect Avenue, suggested paying taxes online and videotaping Council meetings.
- 4. Steven Martinez, 523 Prospect Avenue, asked if this is where the meetings will held. Is there a jail in the Police trailers? The Mayor responded there is a holding cell.
- 5. Bill Brophy, 33 Cresskill Avenue, thanked everyone for their compliments and expressed his support of police.
- 6. Tim Hickey, Randolph Avenue, asked that the decisions made for Resolutions #19 and #20 be given significant consideration.
- 7. Richard McLaughlin, 358 Prospect Avenue, expressed concern about the CSX trains and the dangers the oil tankers present if the train went off the tracks. He also suggested a community garden.

Councilwoman Zamechansky announced that January 13th is the kickoff for "Relay for Life". It will be held at the high school at 6:30PM.

Councilman Manna stated that the Borough has been sued by the land developer and there have been issues with property maintenance at D'Angelo's. He recommended if the property becomes available, the Governing Body participate in acquiring it. This way the Borough will have control of the future of that development.
