# BOROUGH OF DUMONT BERGEN COUNTY, N.J. EXECUTIVE SESSION MINUTES JUNE 3, 2015 6:30 PM

Mayor Kelly called the meeting to order at 6:30PM Flag Salute, Moment of Silence

## **ADMINISTRATOR PERKINS' REPORT**

We met with people from DEP and FEMA Region 2. We met their standards for application to CRS. The CRS special agent received the letter of good standing and is willing to schedule a meeting to discuss the CRS application.

The Clean Communities grant for \$31,000 has been received.

The Memorial Parade went very well. Joe Frank was the Grand Marshall.

After the last meeting, Mr. Perkins called the County to inspect the current Borough Hall for ADA compliance. Jim Thurby, the Director of Disability Services, said the concern is that we make a reasonable accommodation in a temporary facility to address ADA issues. With the signage, the bell and handicap spaces he said we met those accommodations. He did say we should put a piece of molding along the garage door. At the Department Head meeting this morning, we spoke of putting in an automatic garage door opener.

PAGE from PSE&G is a grant to assist families in paying utility bills. If there is a family of three making less than \$88, 617 they can apply for an outright grant of up to \$1400.

#### ATTORNEY'S REPORT

Alfred Egenhofer, Esq. sat in for Mr. Paster tonight.

He reported that Mr. Paster assisted the Police Department and Borough Clerk with several public records requests. There were numerous requests for various information, some of which is not public record and others too general or not specific enough for legitimate requests.

Some further revisions need to be made to the police hiring ordinance. The Police Committee or Ordinance committee should schedule a meeting.

Regarding Landmark litigation-the declaratory judgment action seeking a judgment of compliance with the third round affordable housing obligations is due to be filed on July 7.

It is their understanding that the Land Use Board has adopted the Area in Need of Redevelopment study on the 50 Washington Avenue property and that a recommendation will be forthcoming shortly.

A resolution has been prepared for tonight to award Depew Phase III paving project with alternate 2 only.

The bids for the Solid Waste came in over 26% higher than the prior contract. We are reserving a recommendation as of now. The bids are valid for 60 days from the bid date.

Councilwoman Correa stated for the public that \$45 of the \$88 increase was due to emergency appropriations from 2014. Otherwise, the increase would only have been about \$43.

- 1. Bill Linder, 18 Blanche Court, has had issues with baseballs flying into his yard since the backstop was moved. He spoke to the Recreation Commission but they have not responded. Mr. Perkins responded that he has spoken to the Recreation Director and DPW Superintendent, who said they plan to raise the net at least ten feet.
- 2. Jackie Corless, 52 Larch, asked if the website could give information about the updates on Borough Hall. Is there a deadline for research on Borough Hall and the plans, especially with the D'Angelo property? She knows the answer is usually that it's in litigation but asked if the Council has researched anything with what's going on with Borough Hall and D'Angelo's. Mayor Kelly responded that they have been in contact with the developer and there are things that can't be discussed. Landmark might present a proposal but it's very preliminary. Everyone is looking at the lowest impact on taxpayers. Ms. Corless asked if it would be for the overall benefit for the town in the

long run. Is eminent domain an option? The Mayor responded there is no conclusion yet. Landmark has not given any written proposals.

3. John Chiaia is the attorney for Smentkowski, the Borough's solid waste hauler. They submitted a bid at a good price. The company has granted the Borough an extension until the end of July. Smentkowski assumed the contract two years ago from a prior bidder. They honored the contract of the former hauler. That bid was so low that the previous company went out of business. Although their bid is over 26% higher than the very low previous contract, he cited examples in which bids were rejected and the new bids were even higher. The costs are going up due to Obama care, tire costs, truck costs, worker's comp. and labor costs.

Councilman Manna stated that he and Councilman Hayes have been talking about doing forward budget projections of at least two or three years. This is a prime example.
