Commission Joyce stated that if our by-laws stated that we have the right to suspend her we can. In addition, if our bylaws state that we have the right to reinstate then we can as well. In addition, if the parents' chose to pursue this matter criminally, they would one year to do so. Commissioner Lezette asked that are we allowed to vote on this in an open meeting or does it need to be a special meeting.

Director Como stated that this does not have to be in a closed session, it can be done in a public meeting.

Commission Godlewski made a motion to reinstate Kelly Foss as a Dumont Recreation Coach effective December 1st, 2020. 2nd by commissioner Morrell. Roll call taken motion carried.
