Administrator's Report

50 Washington Avenue:

Mr. Richards reported that eminent domain has been filed on the 27 W. Quackenbush Avenue. The generator has been moved from 50 Washington Avenue. Jeff Schlecht from RSC presented options for the building facade. Asbestos removal has begun. The water flow test in front of the building has been done. Mr. Richards has sent the building plans to four vendors for furniture.

Chief Conner is accepting resumes for a full-time dispatcher. The information is on their website.

The biometric time equipment, which will be installed at Borough Hall and the DPW, has been ordered.

Shared Services:

We have to move municipal court sessions from Bergenfield. We will have shared services in November with Tenafly. We have three shared service agreements with Bergen County, which includes one to borrow a street sweeper, one for vehicle maintenance and one for borrowing Fire Apparatus.

Columbia Avenue II has been approved by Community Development for \$163, 978. New Milford and Washington Avenues will be videotaped prior to paving. First Street project has been delayed due to the weather but will begin soon.

Police Department

In July there were 1,857 telephone calls for service: 84 for medical reasons, 10 for fire and 2 for commitment. The patrol division issued 92 traffic summonses; investigated 40 motor vehicle crashes; 12,361 miles were traveled. The Detective Bureau handled 35 criminal cases, 1 indictable arrest and 6 non-indictable arrest. 32 officers and 8 dispatchers received mandated no tolerance/employments practices training given by the Bergen JIF; 6 officers received discretionary tactical response team training.

- 1. deLyon, 67 Beacon Street, asked about longevity in resolution #191. Mr. Richards explained that there are several members who are grandfathered. He questioned the audit and cited recommendations from 2012 through 2017. He feels that some of the wording has changed but they are repeats. He feels that the auditor charges too much and should be replaced.

Commissioner that Resolution #202 be pulled. The Recreation fees should have a range. Some programs give a discount. Council president Manna said that the ranges will be on September's agenda.
- 3. Gerry Aponte, 88 Hickory, asked about the ranges of Recreation Commission. President Manna replied that the range gives them flexibility.
- 4. Karen Valido, 24 Overlook Drive, asked what the County Sheriff pilot is on the bills list. Mr. Richards will find out.

- 1. John Sansone, 119 Beacon Street, asked if we are adding a property to the bond, how would we have enough money to finish our project. President Manna explained that that was already built into it.
- 2. Karen Valido, Overlook Drive, was sad that the Environmental Committee was disbanded. She said that good furniture is put out by the curb, which could be useful to someone. She found a place in Westwood which will take furniture. The Municipal Clerk will have the information posted on the Borough website.
- 3. deLyon, Beacon Street, commented that the labor hearing be settled as soon as possible. He asked about the Atlantic City Conference payment. The response was that it will take place in November. He said he never received answers to questions he had asked the Mayor sixty days ago.
- 4. Maryann Russini, Roosevelt Avenue, said that the Dumont Community Group will be holding a raffle.
- 5. Dan Monti, 107 Second Street, asked when the depositions will be released pertaining to the employee hearing. Mr. Lafferty responded at the conclusion of the matter. Mr. Monti asked if the Council have seen them. He referred to the borough code, which states that departments will be covered during lunch and asked if that could be looked into since he has found some departments are closed. The code also says that matters will be resolved expeditiously but fourteen months for the personnel matter is too long. Mr. Lafferty explained that the Council cannot comment in public about the specific hearing you are addressing. They will be updated in closed session by the labor attorney. Many issues are beyond the Council's ability to control scheduling. The hearing officer is not bound by the borough code.
- 6. David Corrigan, Esq., Keyport, represents Cathy Romeo, Arthur Cavadias, Ed Rossi and the late Dan Krystyniak. The hearing officer recommended that Mr. Krystyniak be suspended without pay and asked how that would be handled. He wanted a public hearing and will answer questions. He spoke of overtime.
 - 7. Dan Monti asked why they refuse to deal with this in good faith.
- 8. Michael Sullivan, Andover Avenue, feels a human services employee is important. Lawsuits cost too much. He spoke of the overtime. He complained about the sound system. He wants the town cleaned up.
 - 9. Bill Bochicchio, Hillcrest Drive, Joint Land Use Board Chairman, said that he had asked

Dan Krystyniak and Steve Cavadias for crowd control during the farm issues. He said the Mayor and Council needed crowd control also. That was part of the overtime expenses. This ruined those people's reputations.

10. Maureen, 276 Depew Street, asked why, if the overtime budget for the Building Department was \$2,000, they didn't pick it up earlier.
