1. Bruce deLyon, 67 Beacon Street, asked what MEL stands for. Mr. Lafferty replied that it stands for Municipal Excess Liability insurance fund. Mayor Kelly said that the labor attorney has been working on this and the deadline is October 1st, which is why we had a special meeting tonight.

1. Maryann Russini, Roosevelt Avenue, questioned the dates on Mr. Richards' contract and the retro payment. Councilman Manna said there would be a $2\frac{1}{2}$ % retro payment. Ms. Russini asked if 19 Quackenbush is the last property and what the Borough pays. The answer was that there is still one more property. Mr. Lafferty said the Borough would be paying his fees and title fees. The owner had asked if she could stay in her house up to six months but this has not been finalized. The closing will take place in the next three to four weeks. Mayor Kelly added that that property is not crucial to the demolition of the building. She would pay insurance and utilities in the meantime.

2. deLyon, Beacon Street, is concerned about exceeding the bond ordinance for the new municipal complex. He said the demolition of three properties at one time would be less expensive than separate demolition. He asked for the legal fees associated with the property acquisition.

3. Mary Normoyle, 106 Randolph, asked about the spraying by the Mosquito Commission. Mr. Richards explained that the County has come in numerous times to spray in the past. There was discussion as to how to notify people who do not have computers or smart phones. The Mayor said he will be meeting with the County Executive to discuss notifications. Ms. Normoyle brought up the fact that Councilman LaBruno is not at meetings and compared that to former Councilwoman Correa. The by-laws address the number of phone calls permitted.

4. Maryann Russini asked for the name of the person in the County who said they sprayed the whole town. She was told it was only certain sections.

Motion to close: Councilwoman Stewart Second: Councilman Manna All in favor. Motion to adjourn: Councilman Manna Second: Councilwoman Stewart All in favor.
