1. Maryanne Russini, Roosevelt Avenue, stated that she was a member of the Beautification Committee until December 31st. She looked for the application but it was no longer there. Mayor LaBruno said that it was open from November but he had to get the agenda set.

2. John Sansone, 119 Beacon Street, questioned the status of the CFO position.

3. Tom Kelly, Beacon Street, asked if there is a set number of volunteers for Resolution #57. He would like to see the Ordinance changed to accommodate more volunteers.

4. Bruce deLyon, 67 Beacon Street, spoke of the money paid for Sustainable Communities and a part-time CFO, which would be a total of \$62,000. He asked for confirmation that the Temporary Budget is for three months. Are there different professionals this year than last? Mayor LaBruno replied that they were the same. Dr. deLyon asked how the positions for Resolutions #50-57 were advertised. The Mayor responded it was posted on the website, on Facebook and he's pretty sure there was an email blast. Dr. deLyon suggested the Beautification Committee be expanded to include more people.

5. Mary Normoyle, 106 Randolph Avenue, asked the Mayor if the Borough Attorney or any of his colleagues belong to any other LLC's or connected to builders or developers. Mr. Leibman replied that some of his partners are involved in other businesses. He said it is well-known that one of his partners is involved in the development business but as far as he knows, not in Dumont.

1. Bruce deLyon, Beacon Street, asked if the radio bid was rebid. The Mayor said that there was only one bidder.

2. Tom Kelly, Beacon Street, asked about the closed session the last meeting and if it is something that is allowed. Mr. Leibman said there will be no discussion at a public meeting as to items in closed session. They are in closed session for a reason. Mr. Kelly spoke of the rent control ordinance. He asked if there were certain developers consulted who said they weren't interested. Was there any cost for the map from the planner? Can residents come to the meeting? The Mayor said that the dates of the meeting are on the calendar. Mr. Kelly said that this issue first came up because there was a property owner challenging the rent leveling ordinance and that they had found a loophole. He is wondering how discussion of that turned into developers not interested in Dumont as a place to develop. Wouldn't this loophole affect other property owners?

3. Maryanne Russini, Roosevelt Avenue, asked if we have started collecting money from the PILOT. Mr. Leibman replied that they are having a meeting tomorrow on that. Ms. Russini asked if there is a max a town can use for petty cash. Mayor LaBruno said that she should email the question to Ms. Connelly or himself.

4. John Sansone, Beacon Street, wanted to follow up on the PILOT. Do they pay

taxes, also? Mr. Leibman replied that it's his understanding that they have to continue to pay the taxes due on the land value prior to when the PILOT goes into effect. Mr. Sansone spoke of the Beautification Committee planting trees.

Motion to adjourn: Councilman Englese Second: Councilman Chae All in favor.
