Councilman Geist maintained that the revenues projected were in line with what was projected the year before instead of what was actually brought in, which was more.

Councilman Manna remarked that had Councilman Geist been present from the beginning of the process, they could have worked through a number of the issues he brought forth. Looking at the five-year financial projection, the fact that we had decided

to convert bond anticipation notes into long term financing of bonds and a \$15,000,000 bond issue, we still have to maintain the Borough's operations. Going through the process and reintroducing the budget, the base cost has been reduced.

# **ORDINANCE**

**#1519** Bond Ordinance Providing for Various Capital Improvements by the Borough of Dumont, Appropriating the Aggregate Amount of \$15,400,000 therefor and Authorizing the Issuance of \$15,075,000 Bonds or Notes of the Borough to finance the cost thereof Motion to waive formal reading: Councilman Morrell

Second: Councilman Riquelme

All in favor.

Councilman Manna explained that although the Borough does not have to spend the whole amount but it gives us the flexibility to work with a budget we're comfortable with and get the most for the money. This bond will also be used to pay the rent for the trailers and borough hall. It has been reviewed by the State and the rating agencies.

Councilman Geist remarked that he is not in favor of the bond ordinance. Although the Local Finance Board granted the Borough a waiver of the down payment but in reality, we are borrowing more money.

There was discussion about using the PILOT money to pay down the bond.

Mayor Kelly explained we spend \$120,000 a year to rent borough hall and the trailers. The current borough hall does not suffice and the trailers are outliving their usefulness. We have spent several years now and gone over many ways to solve our borough hall issue. Councilman Di Paolo said that \$15,000,000 is a lot of money, especially when it would have been less costly to share with Bergenfield. However, if we don't have the waiver from the Department of Community Affairs, the taxes would triple for taxpayers. We would also have to pay for the police department trailers and borough hall through taxes. He suggested hiring a project manager so that money is not wasted. Motion to open to the public: Councilman Morrell

All in favor.

1. Lili Binney, 32 Roxbury, asked the status of the Board of Education lawsuit. Mr. Paster said it is pending appeal. What is being contested is the Borough's right to deem the area in need of redevelopment and whether the proposed use with the affordable

housing component is an appropriate use under the deed. The affordable housing component is no longer an issue. Ms. Binney asked the square footage of the current borough hall. How much would the \$15,000,000 bond ordinance cost the taxpayers? Mr. Herr responded that from 2018 to 2042 taxpayers would be paying approximately \$4,208.

2. Bruce deLyon, 167 Beacon Street, clarified that the trailer and borough hall rents are not in the 2017 budget and that we are paying for them through the ordinance.

1. Lili Binney, 32 Roxbury, confirmed that Mr. Paster wrote Mr. Herr's contract. She asked the status of the farm roll back tax and the amount. The Mayor said that we are still negotiating with the D'Angelo family. Mr. Paster responded the amount is \$205,000. Ms. Binney asked if litigation with Landmark is over. Mr. Paster replied that there still has to be a filing of stipulation of dismissal of the builder's remedy action, which is 45 days after the memorialization. There was discussion about Green Acres and applying for an Open Space Grant.

There was discussion between Councilwoman Correa and Councilman Morrell regarding the Councilman requesting donations from the professionals and the process, to buy a trailer for the Recreation Department which cost \$1500. Councilman Morrell remarked that there was no problem giving to the Dumont Community Group

- 2. Andrew LaBruno, 108 E. Linden Avenue, president of the Dumont Community Group, said he has never received a check from Mr. Paster. He has a 501C3 for this town.
- 3. Bruce deLyon, 67 Beacon Street, said that following the architect's presentation, he still didn't have very much information. Continue the rentals. The Mayor said that now that the ordinance has been adopted, we will be able to hire the architect to go forward with more detailed plans. Mr. deLyon stated that upkeep on a new building is important.

Councilman Manna said a number of them went to a municipal complex in Wanaque and gleaned some good ideas from them.

- 4. Tom Gorman, 46 Wilcox, asked where the trailer is going. Councilman Morrell responded behind the swim club. There was discussion about the current storage units. Mr. Gorman asked about the swim club. The response was that the borough owns the land and the swim club has a lease with us. Mr. Gorman stated it doesn't look good to ask professionals for money.
  - 5. Andrew LaBruno, 108 E. Linden Avenue, asked the status of the grant writer.
