1. Lili Binney, 32 Roxbury, asked for an explanation of $\$ 15,000$ to McNerney for 511 Washington Avenue. The response was that it was part of the tax settlement. Ms. Binney asked for corroboration that there are three separate tax assessments on Resolution \#191. Bill Betesh, Borough Tax Appeal attorney, explained that the D'Angelo's settlement has several components: the tax appeal that was brought by D'Angelo's for a reduction in their assessment primarily on their larger parcel, which has now been withdrawn; a second action was brought by the Borough, called the farmland assessment, after the farm closed, which includes 2012, 2013 and 2014. This is why the resolution assessment is for $\$ 800,000$ three times. The entire tax issue will now be resolved. Jim Anzevino, Borough Tax Assessor, said that this is a pretty big win for the Borough because our appraisal report came in at about \$550,000. Landmark's appraisal came in at about $\$ 525,000$. We settled this for $\$ 800,000$ for the years 2012, 2013 and 2014, substantially higher. There was discussion about the taxes paid on both parcels. The total taxes D'Angelo's must pay is \$77,824. 2012 is $\mathbf{\$ 2 5 , 4 5 6}$, 2013-\$25,984 2014 $\mathbf{\$ 2 6 , 3 8 4}$.
2. Tom Gorman, 46 Wilcox Street, asked about CO2 certification for the new police cars. The Mayor will check. In answer to Mr. Gorman's question referring to Resolution \#203, Mayor Kelly stated it pertains to the new Borough Hall. The closed session item pertains to the Lutheran Church on Washington Avenue, which was being considered for Borough Hall.
3. Bruce deLyon, 67 Beacon Street, pointed out that page 2 of the audit resolution is missing, which he finds very convenient. He said that all prior audits and budgets are missing from the website. He spoke of unresolved and new recommendations in the past audits and the seventeen for this year. He accused everyone of incompetency. We need a forensic audit. He spoke of what is lacking in the town. The corrective action was adopted last August but nothing was corrected. What is the auditor doing to guide employees? Councilman Manna replied that there was no oversight and that is why during the interviews for CFO, we wanted to make sure they knew what needed to be corrected. Within the past three weeks that the new CFO firm has been working, they
have addressed five of the twelve repeats and are currently working on two of the new ones. Resolution \#197 is missing the second page.
4. Lynne Vietri, 41 Wilkens Drive, said that Resolution \#191 should be thrown out because the owners named are deceased and $\$ 25,000$ a year is too low. The response was that the deed is still in their name. Councilman Geist stated that our hands are tied on this because both appraisals are close in number.
Mr. Betesh explained that the State of New Jersey encourages farming and gives them a very favorable assessment. However, when the farm closes, there's a special statute that triggers fair market value on that property both in the year the farm closes and the two years prior. You need to have proof that the land is worth what we say it's worth and they have the ability to challenge that. Our experts valued the small parcel at about $\$ 550,000$. Landmark's appraisal was valued at $\$ 525,000$. The settlement being agreed to sets the assessment at $\$ 800,000$ for each year. If this case were to go to court and the judge will look at the proof submitted. It is likely the judge will likely recommend a value in the appraisal range. Ms. Vietri questioned the acreage necessary to deem the land a farm; discussion ensued.

1. Lili Binney, 32 Roxbury, asked the status of Chief Conner's contract. The Mayor replied that the attorneys are working on it. Ms. Binney asked the status of the Open Space Grant. The Municipal Clerk had checked-it is a process; no deadline for approval was given. Ms. Binney asked about the report regarding the Lutheran Church being used for a Borough Hall. It will be discussed in closed session. Ms. Binney asked if there was a statute of limitations on tax appeals. Mr. Betesh replied that you can file a tax appeal in the current year. Ms. Binney asked what constitutes an open hearing. Mr. Paster responded that anyone can come in and watch. Ms. Binney asked how our referendum resolution differs from Assemblywoman Schepisi's. Mr. Paster replied that Schepisi's resolution asked whether the Building Department should stop issuing building permits effectively in contravention of court orders, which is not going to happen. No construction official is going to risk his license or go to court on a contempt charge. Our resolution states that the Governor and the Legislature do their jobs, fill out the COAH Board and change the statute, if necessary, to give the municipalities the tools to administer Affordable Housing obligations that are practical and achievable. After discussing his concerns with the Assemblywoman, she told him to go ahead and adjust it.
2. Harry Vassallo, 137 E. Quackenbush. He owns 143 E. Quackenbush and 144 Madison Avenue. He had spoken to Steve, the zoning officer, and purchased 144 Madison Avenue. He has now received a "cease and desist" from the Building Official, Mr. Renaud and wants it rescinded. The Mayor will check into it.
3. Betty Krystyniak, 569 Prospect Avenue, requested that her husband and the other employees who currently have a common attorney, be permitted to keep him.
4. Lynne Vietri, 41 Wilkens Drive, asked what account the rollback tax money would go into. Councilman Manna said it would go into surplus. Ms. Vietri said that the overlay zone will be a problem for the small businesses.
5. Bruce deLyon, 67 Beacon Street, said that the budgets are no longer on the website. He commented on the personnel case. If the employee wants to waive his rights and have the hearing in public, they should be able to. He feels that trying to disqualify an attorney is a waste of money.
6. John Sansone, 119 Beacon Street, asked the plan for Washington Avenue. The Mayor replied that the County will be repaving Washington Avenue. The curbs and sidewalks will be part of the construction.
7. Tom Gorman, 46 Wilcox Street, reiterated his request for laptop computers for the people on the dais.
8. Daniel Rowell, 106 Randolph Avenue, asked Councilman Morrell when his term expires. He replied it ends the end of the year. Mr. Rowell said that the Mayor, Council members Riquelme and Di Paolo should resign because they voted for Mr. Paster.
9. Michael Sullivan, 125 Andover Avenue, asked if the burglar alarm has been taken care of at 80 W . Madison Avenue. He spoke of the referendum.
10. Maryanne Russini, 141 Roosevelt Avenue, spoke of the employees' charges and the money it costs. It's a good idea to hire an interim administrator. We should have a full-time Mayor to oversee things. She had said in the past that there will be more work involved for the Building Department with Landmark construction.
