BOROUGH OF DUMONT BERGEN COUNTY, N.J. GOVERNING BODY MEETING MINUTES DUMONT SENIOR CENTER APRIL 2, 2019 6:30 PM

Mayor Kelly called the meeting to order.

Flag Salute, Moment of Silence

Sunshine Law: The notice requirements of the Open Public Meetings Act of the State of New Jersey have been satisfied by the inclusion of the date, time and place of this regular meeting in the annual schedule and notice of regular meetings of this Governing Body. Such annual schedule and notice of regular meetings are posted at Borough Hall, was sent to *The Record* and the *Ridgewood News*, posted on the Borough website and filed with the Borough of Dumont.

Roll Call:

Council members Chae, Englese, Manna, Stewart-present Council members LaBruno and Rossillo-absent Mayor James J. Kelly-present

Motion to Accept Agenda as presented: Councilman Manna Second: Councilwoman Stewart All in favor.

Mayor and Council Work Session:

Budget Process-Councilman Manna explained the areas that the Finance Committee, CFO and Administrator look at are Operations, Capital and Debt Service. Department Heads are asked to provide their needs for the year, which the Finance Committee reviews to differentiate wants as opposed to needs. Grants are also considered. Councilwoman Stewart said that the number is nowhere near to the figures on social media. They will work on the budget to see if they can get the figure lower. She applauded the volunteer fire department and hopes we can do right by them and the other volunteer organizations.

Contractor Ordinance-Ordinance #1411 was adopted in 2010. The State ordinance would put us in line with every other municipality that has the contractor's ordinance in place. He is recommending that our ordinance committee modify what we have now to what the State uses.

Liquor License Fees-Councilwoman Stewart stated that we have not raised our annual liquor license fees in a long time. The ordinance committee will be reviewing it.

Councilman Manna has been in touch with Citizens for Improving Affordable Housing. They have been working to change some of the rules that apply to COAH and the affordable housing situation. They have submitted legislation, which might help Dumont. He will circulate the information to the rest of the Council to get their thoughts on this. This will hopefully help us in 2025 when the next round begins. The Mayor said that tonight is the introduction of the 2019 budget. CFO Sercan Zoklu stated that the budget tonight reflects an increase of \$92.00 on an average home assessed at \$307,000. Major increases are the Bergen County Utility Authority in the amount of \$113,000, the capital improvement fund in the amount of \$120,000, police salaries in the amount of \$210,000, debt service \$95,000 and contractual obligations \$60,000. The Finance Committee will meet to reduce the increase even more. The hearing on the budget is scheduled for May 7, 2019. At that time the public can ask questions.

The COLA ordinance that is being adopted tonight allows the Borough to go to an additional 1%. This 1% is banked. He said he has not heard of a municipality which does not adopt this ordinance. Councilwoman Stewart explained we passed this ordinance last year and this amount has not been touched.

1. deLyon, 67 Beacon Street, asked if furniture, computer wiring, demo of the two properties and remediation of the two properties is included in the bid. He and his wife don't understand why Mrs. Connelly does not have a contract. She is basically an

administrator. He finds it very strange that the second in command would not have a contract to specify sick days, etc. He asked about Resolution #117 and whether it is in the bond ordinance. Councilman Manna said the demolition of the houses is included in the bid.

2. Maryann Russini, Roosevelt Avenue, asked whether the bid covers just building the borough hall and demolition of the two properties. Where would the remaining items be paid from? Who would pay for remediation, if necessary? She asked if the Open Space grant due March 30th included the playground.

3. Aleks Tandyrak said he's been in construction and contacted the Building Department because he had some concerns. He has spoken to the Administrator and the Project Manager and has some concerns about the overall design. There are going to be so many changes from the bid. He strongly opposes of the award of this bid. It should go out for rebid. It seems like a gross overdesign. Even though you plan on awarding to the low bidder, it reeks of impropriety. He feels using the borough engineer on this project is a conflict of interest.

#1562 Ordinance to Establish a Stigma-free Committee Motion to waive formal reading: Councilman Manna Second: Councilwoman Stewart All in favor.

Councilwoman Stewart said they have been undertaking our stigma-free program and came to the decision that it would have more standing in the community if it was a standing committee. There are seven people interested in becoming members. There is nothing more important than the mental health of our children. By establishing this committee, hopefully people will become more aware of these issues. The Mayor commended the councilwoman for getting this committee established. #1563 Amendment of Ordinance #1555, Section 2-Establishment of the Economic Development CommitteeMotion to waive formal reading: Councilman MannaSecond: Councilman EngleseAll in favor.

Councilman Chae explained that instead of five members, we now have seven. Seven applications were received from residents and they felt they all should be included.

Councilman Manna stated that he had asked that Council members Chae and LaBruno meet with our COAH specialist, Mr. Szabo and have him help them navigate the initial stages of this committee as well as 2025, when Fair Share Housing gets involved again.

Motion to open to the public for general comments: Councilman Englese Second: Councilwoman Stewart All in favor.

1. deLyon, Beacon Street, stated that the funding of Resolution #88, 23 W. Quackenbush, would be Bond Ordinance #1559 but he doesn't see that funding component. He questioned the down payment on several bond ordinances. After submitting an OPRA, he figures there is \$2,700,000 left. He asked the plan if we fall short. He feels we are overdue for a forensic audit. He complained that when he sends questions, he doesn't usually receive answers. Mayor Kelly will check and get back to him.

2. Mary Normoyle, Randolph Avenue, asked the Mayor and Council President what their plans are after leaving the Council. She questioned the procedure in hiring the court administrator. Councilwoman Stewart explained that the vicinage posts the position, review the applications and they make the recommendation of those who should be interviewed. A team consisting of Dumont's judge, a judge from Hackensack, the woman who oversees all the court administrators, her assistant and one member from the municipality decide which applicant should be hired. Ms. Normoyle asked if the properties on W. Quackenbush are vacant. Mr. Leibman responded that 23 W. Quackenbush has a use and occupancy, which was part of a lengthy OPRA request provided to her, which stated June.

3. Maryann Russini, Roosevelt Avenue, questioned the salary of the new court administrator. She would like a comparison of what other towns pay their court administrators.

Motion to close to the public: Councilman Manna Second: Councilman Chae All in favor.

Councilman Manna asked who the contact for FARM'd is. He would like to talk to whoever it is about COAH. The answer was Tom Kelly.

Motion to adjourn: Councilman Englese Second: Councilman Chae All in favor.
