MAYOR'S REPORT

Saturday will be the actual anniversary of the Borough of Dumont. We were incorporated as the Borough of Schraalenburgh. We'll have other events such as fireworks in September.

ADMINISTRATOR'S REPORT

Mr. Richards said that Columbia Avenue and New Milford Avenue railroad crossings are scheduled for repair by the Department of Transportation. They are just waiting for CSX. He enlisted the assistance of Assemblywoman Schepisi, explaining that New Milford Avenue, especially, is in dangerous condition.

There was a complaint that the Garden Homes contractors were using the back gate for access for construction equipment, which was against the developer's agreement. He had a talk with them and they have ceased using that gate. If anyone sees any problems, call Mr. Richards and he'll take care of it.

The Borough has used Direct Install in the past. They have made replacement lighting, heating and air conditioning more efficient and more appealing because they are now funding 80% as opposed to 70%. This is available to schools and non-profits.

Police Department

In May, there were 1,997 telephone calls for service-88 for medical reasons, 12 for fires and 9 calls for commitments. 98 traffic summonses were issued; there were 2 DWI arrests, 35 motor vehicle crashes investigated, 31 burglar alarms responded to, 9,312 miles were traveled in patrol activities. The Detective Bureau conducted 10 firearms investigations, handled 28 criminal cases, investigated 8 Domestic violence incidents, with 2 mandated arrests. There were also 2 drug-related arrests.

As of June, there was a total of 119 calls. As of now, they have had 689 calls.

- 1. deLyon, 67 Beacon Street, said that although he asked #207 and #216 be discussed, the Council did not. He spoke of the amounts in Ordinances #1567 and #1558 and the 6-year plan. He had asked when increases would be added to tax bills. Councilwoman Stewart answered that it would not impact anyone until August, 2020. We do not know exactly what we will be borrowing or at what rate. Dumont has a AA rating. Councilman Manna stated that the 6-year plan is fluid and sometimes priorities cause it to change.
- 2. Virginia R, 11 Richard Drive, spoke of issues with a tree in front of her house. She hasn't gotten any response.
- 3. Mary Gilmore, 26 Fleetwood, feels that the tracks should be fixed. The Mayor said that we constantly call and complain. The DOT is in charge of repairs.
- 4. Lynne Vietri, 41 Wilkens Drive, thanked the Mayor for attending the athletic awards dinner. She asked that Council meetings not be scheduled the same day as the Board of Education meetings.
- 5. Maryann Russini, 141 Roosevelt, asked if the hiring of a part-time violations clerk is a new position. Councilwoman Stewart explained that we had a full-time court administrator and that position was replaced by the part-time clerk. Ms. Russini asked about #207 and where the tank is. The response was at 50 Washington Avenue. Ms. Russini asked if we are buying the property on New Milford Avenue for rental to Asplint. Mr. Leibman stated he has not been directed to have any negotiations to purchase the property. He has spoken to the representative from DEP. The resolution to file litigation has been approved. It is his hope we don't have to get to that point. He has broached a

solution but has not had a response from Asplint's attorney. Ms. Russini asked if there has been any update on Gina's Field and was told it is on hold for now. She said the engineer had reported that the playground equipment was unsafe. Councilwoman Stewart has spoken to him and he said he had misspoken.
