A meeting with FEMA will be held for the Borough of Dumont April 13th at 6:00PM The Borough will be going out to bid for garbage collection and disposal. The DPW has used fifty-one tons of asphalt so far this season to patch potholes. There will be a meeting April 9th with the County Executive to discuss CSX issues. The shredding program was held March 21st at no cost to the Borough. We received \$136,576.63 from Homeland Security for storm reimbursement. The County reimbursed the Borough \$2,960 for plowing county roads. The DPW passed the Right to Know inspection today. There will be a Memorial Day Parade May 25th at 9AM.
