She said that several appointments are new.

2. DeLyon, 67 Beacon Street, asked why #16-30, Temporary Budget is on the agenda. He asked what #16-39 is about. Mayor Kelly explained that many towns have this in place already. At the last meeting a person spoke for forty-five minutes and people left. Most towns have a five minute limit. This resolution provides a ten minute limit, which allows everyone time to speak. Dr. DeLyon asked if the public would have an opportunity to participate in the hiring process of a new borough administrator.

Mayor Kelly said he would bring this up to the Personnel Committee.

#16-39 Regulation of Public Comment during Council Meetings

Councilwoman Correa commented she doesn't believe there should be any time limit for residents to express their concerns.

Councilman Di Paolo stated that there are so many issues at this time there should be no limit.

Mr. Paster responded that the resolution states that the time limits can be relaxed upon motion and assent from a majority of the Governing Body seated at the time it feels that relaxing of the time limit is appropriate.

Councilwoman Zamechansky stated that it's great that people do research and are passionate about issues. When people get up and speak forty minutes on an issue and

another person speaks twenty minutes on the same issue, people leave. It's not fair to the residents.

Councilman Hayes agreed with the Councilwoman. Residents have issues besides those from the farm district and they end up leaving because they can't wait until late at night to speak.

All in favor.

- 1. Bill Brophy, 65 Margaret Court, asked about guidelines in Robert's Rules. Mr. Paster responded that Robert's Rules does call for procedure but it doesn't put specific time limits. Enough members of the Governing Body approached him to see how we can limit some of the filibustering going on. This resolution is legal. A lot of towns limit speakers to three minutes.
- 2. Judy Parker, 55 Susan Drive, Closter, encouraged the passing of the resolution. Closter allows five minutes. When one person speaks for forty minutes and others are waiting to speak, it isn't fair.
- 3. Jerry Drummond, 60 Blauvelt Avenue, stated that the Freeholders allow three minutes. He agrees with Gregg-you should be able to say what you want to say in ten minutes. If not, you can always write it out and give to each of the council members.
- 4. Maryanne Russini, 141 Roosevelt, doesn't like the resolution. Maybe the people who abuse the time can be curbed. Maybe we should put a clock for people to see. Also, the council should put their phones away.
- 5. Sabino Rodano, 111 Cresskill Avenue, asked if there is a provision in the resolution for the people of the town to ask for a suspension of the rule. Mr. Paster replied there isn't. A speaker can always ask for extra time.
- 6. Rachel Bunin, 9 Poplar, stated that they need a venue to provide information and so far the Council meeting is the only one they have found. If another venue could be provided, it would be great.
- 7. Tom Kelly, 70 Beacon Street, is opposed to the limitations, especially if it is in response to one long-winded speaker. Council meetings are the only place they feel they can get answers. Mr. Paster said that putting limitations at a specific meeting would be arbitrary. By setting a policy that can be relaxed, the public is on notice that the limit can be relaxed.

Mayor Kelly stated that it is less about the Governing Body's time being taken up and more about the residents' time. The Council stays for closed session many times until late at night. The Council has email and phones people can use to access them. Also, if they could send questions ahead of time it would make things go faster. He said he is in favor of this resolution.

Councilman Di Paolo stated that this resolution could use more comment and public discussion.

Councilwoman Correa stated that she has only dealt with this firm in the past six weeks. Every email and question has been answered in a timely manner. Contracts should not include "past practice".

Councilman Di Paolo said that the Mayor sent an email with his rationale for putting this resolution on the non-consent agenda. He feels the Mayor made a good case to look into it further. He feels that if there are concerns they should be discussed ahead of time. He would like to make a motion to table this resolution so that it can be discussed.

- 1. De Lyon, Beacon Street, stated that Councilman Hayes' comments are ridiculous. "You say you are bipartisan but you have a plant in the audience". We need to have a bipartisan position in this town. He complimented the council members who got a reduction in professional fees. He would like to know the details of the contracts, etc.
- 2. Chris Snell, 84 Franklin, said they follow all the ELEC processes, contrary to Councilman Di Paolo's comment that the Republicans had not filed when he looked for the information by the deadline. Mr. Snell would like the record corrected.
- 3. Maryanne Russini, Roosevelt, asked if there could be a mailbox so that residents can submit questions ahead of time. The Mayor said a mailbox could be set up.
- 4. Tom Kelly, 70 Beacon Street, agrees with retaining Maser but information should be verified. The Mayor said they are planning on meeting with Maser next week to go over information and where we stand with Landmark.
- 5. Tim Hickey, 165 Randolph, asked for everyone to work together for the betterment of Dumont. Special thanks to Councilwoman Zamechansky for the work she does with Celebrations.

Mr. Paster said that as of yesterday, our next day in court on the declaratory judgment and builder's remedy action is January 28th. It's a case management conference.
