ORDINANCE AMENDING CHAPTER 306-18 and 306-20 PROPERTY MAINTENANCE OF THE DUMONT CODE

An Ordinance of the Borough of Dumont, County of Bergen, State of New Jersey

BE IT HEREBY ORDAINED by the Mayor and Council of the Borough of Dumont, in the County of Bergen and State of New Jersey, that Chapter 306, Section 18 ADOPTION OF STANDARDS of the Borough of Dumont Code shall be amended as hereinafter provided:

International Property Maintenance Code 2018 shall replace the words BOCA Property Maintenance Code 1981, or any reference thereto, from that section;

BE IT FURTHER ORDAINED that Chapter 306, Section 20 CONSTRUAL OF PROVISIONS of the Borough of Dumont Code shall be amended as hereinafter provided: International Property Maintenance Code 2018 shall replace the words BOCA Property

Maintenance Code 1981, or any reference thereto, from that section;

Invalidity. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

Severability. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Effective Date. This Ordinance shall take effect upon final passage and publication pursuant to law.
