ORDINANCE AUTHORIZING THE PURCHASE OF REAL PROPERTY KNOWN AS LOT 6 IN BLOCK 1215 ON THE TAX MAP OF THE BOROUGH OF DUMONT, MORE COMMONLY KNOWN AS 27 WEST QUACKENBUSH AVENUE

WHEREAS, the Borough of Dumont is currently seeking to acquire certain property situate within the borough, to wit, Lot 6 in Block 1215 of the Dumont Tax Map, otherwise known as 27 West Quackenbush Avenue; and

- WHEREAS, it appears that the Borough seeks to purchase and the owner, Dwain Asplint, has expressed a willingness to sell the said parcel of property, and;
- WHEREAS, the Council has previously adopted Bond Ordinance 1519, authorizing and appropriating funding for the acquisition of the referenced property, and designating same as necessary for an explicit public purpose, and;
- WHEREAS, contractual terms have been informally negotiated and the Borough now seeks to execute a contract for acquisition of the property, and;
- WHEREAS, the said parcel is adjacent to the Borough Hall property and is intended for expansion of the current municipal facilities, a dedicated public purpose; and
- WHEREAS, the Chief Financial Officer has certified the availability of funds to close the purchase of the property sought to be approved hereby.
- NOW THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Dumont, pursuant to N.J.S.A. 40A:12-5, that the Mayor, Municipal Clerk, and Borough Attorney be and hereby are authorized to prepare, execute and close a contract for acquisition of the property Lot 6 in Block 1215 of the Dumont Tax Map, otherwise known as 27 West Quackenbush Avenue, for a purchase price of Four Hundred Thousand (\$400,000.00) Dollars plus use of existing borough property as further consideration, pending final adoption and publication hereof pursuant to statute; and
- **BE IT FURTHER RESOLVED**, that a copy of this Ordinance shall be served upon the attorney for seller, David M. Watkins, Esq. upon adoption and publication hereof; and
- **BE IT FURTHER ORDAINED,** that all steps necessary pursuant to the aforementioned statute section shall be complied with prior to closing of the sale of the said property, and
- **BE IT FURTHER ORDAINED,** that if the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance, and
- **BE IT FURTHER ORDAINED,** all ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency, and
- **BE IT FURTHER ORDAINED,** this Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
